

International Officers and Directors—1950-1951

Here are portraits and brief biographies of the officers and directors of Lions International. They compose the Board of Directors which sets the policies of the Association. Most of them were elected to their respective offices at the convention held in Chicago last July; others are completing terms of office to which they were elected in 1949. The dates of service are shown in parenthesis.

H. C. PETRY, JR., Carrizo Springs, Texas, was elected President of The International Association of Lions Clubs at the International Convention held in Chicago, Illinois, in July, 1950, having previously served as International Third, Second, and First Vice-President and as a Director. He has served four consecutive years as Chairman of the Board of International Relations. He is a Charter and Master Key member of the Carrizo Springs Lions club and has held the offices of zone chairman, deputy district governor and governor in District 2-A. President Petry is a graduate of Westmoorland College and the University of Texas from which he received his law degree. He is now a successful business man and attorney, heading his own firm of Petry and Dean. He is the president of the Dimmit County Bar Association, and is a member of the State Bar Association of Texas and the American Bar Association. He is also a director of the Union State Bank of Carrizo Springs. President Petry is a steward in the Methodist Church and is also active in community affairs. He and his wife, Josephine, have two sons—Boothe and John.

WALTER C. FISHER, Queenston, Ontario, Canada, served as International President during the fiscal year 1949-50, having previously served as Director and as International Third, Second, and First Vice-President. In the St. Catharines Lions club, he held the offices of director and president, and in District A-2, he served as governor. He has also been president of the International Association of Lions clubs of Canada. Lion Fisher operates a large fruit farm. He has served as vice-president of the Niagara Fruit Growers Association, and as director of the Ontario Fruit Growers Association. He is married and has three children.

HAROLD P. NUTTER, Camden, New Jersey, is First Vice-President of Lions International, having previously served as Second and as Third Vice-President. Lion Nutter has served as

an International Director for two terms and as Chairman of the Board of Governors. He is a Master Key member and has held the offices of president and director in the Camden Lions club. In the district he served in the offices of governor and deputy governor. Lion Nutter was born in Milford, Delaware, and received degrees from the University of Delaware and Temple University. He is vice-president of the Nutter Mortgage Service. Vice-President Nutter is active in church and community affairs; he is married and has one daughter.

EDGAR M. ELBERT, Maywood, Illinois, was elected Second Vice-President at the International Convention in Chicago, Illinois, in July 1950. He had previously served as International Third Vice-President and as an International Director. Twice he was elected to the governorship of district 1-A. He is a Key member of the Maywood Lions club, in which he has held the offices of director and president. Lion Elbert was born in Villard, Minnesota. He was graduated from the Concordia Teachers College, River Forest, Illinois, and attended James Millikin University, Valparaiso University, and the University of Chicago. Lion Elbert is engaged in the real estate business. He is a member of the Evangelical Lutheran Church; is married and has one son.

S. A. DODGE, Detroit, Michigan, was elected Third Vice-President at the International Convention in July, 1950. Previously he had served as an International Director and as district governor for district 11, Lower Michigan. He is a Key member of the Detroit (Northwest) Lions club, and has served that club as president. Lion Dodge was born in Avoca, Michigan, and is a graduate of the University of Michigan School of Business Administration. He is vice-president and treasurer of the Solventol Chemical Products Company and is also a Certified Public Accountant. He is a member of the Presbyterian Church, and a Mason. Lion Dodge is married and has two children.

R. ROY KEATON, Director-General, is the active managing officer of The International Association of Lions Clubs. He was appointed to that position by the International Board of Directors in July, 1950, after five years of outstanding service as Assistant Secretary - General. Director - General Keaton became a member of the Lions club of Weatherford, Texas, in 1929. Since 1934 he has been in the employ of Lions International, having served with extraordinary distinction as a Special Representative and as Lions State Secretary in Texas. Lion Keaton is a graduate of Southern Methodist University at Dallas, where he received both his Bachelor and Master of Arts degrees. Recognized as one of the country's outstanding speakers, his services in that capacity are in constant demand. Lion Keaton lives in Flossmoor, Illinois, with his wife, Elizabeth, and their two children, Larry and Sherry. He is a Mason, a Knight Templar, and a Shriner.

MELVIN JONES, Secretary-General, was born in Fort Thomas, Arizona. At the age of 20 he went to Chicago to study law. Later he went into the insurance field and operated his own agency. In 1914, as secretary of the Business Circle of Chicago, he wrote to a number of other unattached clubs, with the idea of forming an association. It was not until 1917, however, that representatives of 27 clubs met in Chicago, and later in the same year in Dallas, and formed The International Association of Lions Clubs. Lion Jones was elected Secretary-General at that time, and in July, 1950, that title was bestowed upon him for life. He now serves the Association as Consultant and Advisor and devotes the major portion of his time to the development of Lions International City. Lion Jones lives in Flossmoor, Illinois, with his wife, Rose, who is an internationally known golfer. He is a Grand Master Key member and a Mason.

That ski group from Steamboat Springs, Colo., use their skis in the regular way when snow is on the ground. In summer they adopt the roller device which they used in the Lions parade. This is a rubber roller which acts like a bicycle coaster brake. When the ski moves forward, the roller turns freely. When back pressure is applied, the roller locks in its specially designed holder and enables the skier to step forward easily.

The skiers do not have the straight military march because they sway as they move the skis. Each skier has at least 10 pounds additional weight on his feet with the skis and rollers in addition to band instruments. Usually there are 50 skiers in the group, 27 boys and 23 girls, all but three or four of them attend high school, the remainder being in grade school.

The group was sponsored by the entire state of Colorado Lions, who furnished them with new uniforms for the trip, and paid all expenses of the trip to Chicago. Lion Bob Flanders is bandmaster of this group which has been playing together for about three years. However, there has been a ski band in the schools of Steamboat Springs since 1936. Flanders has been in charge of the present band for two years. The band is used about five times during the year, generally at skiing carnivals. This was the original idea—playing for the ski carnivals—but it has taken hold and become quite popular elsewhere. The youngsters practice regularly, and are more at home in the snow than on rollers. There is an average of 210 inches of snowfall in their vicinity each year, and this enables them to practice almost daily for a period of six months. District Governor J. R. Smith of Steamboat Springs was in charge of the group while in Chicago. Oldest youngster in the group is 18, one of the grade school boys is 11, and two others are 12 years of age.
