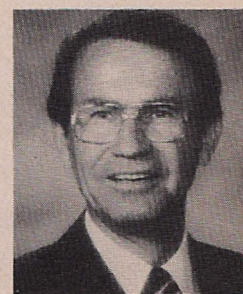


Officers and Directors Lions Clubs International 1980-81

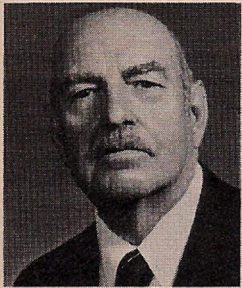
Shohei Arimoto

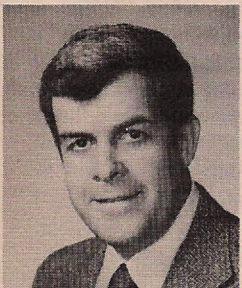
Premchand Bafana
