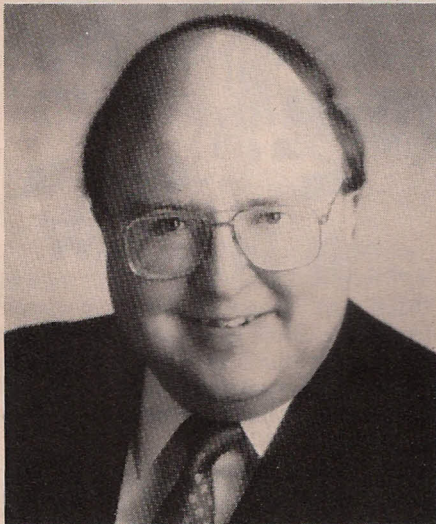
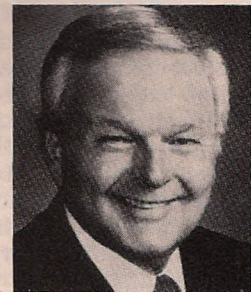


# Officers and Directors Lions Clubs International 1990-1991

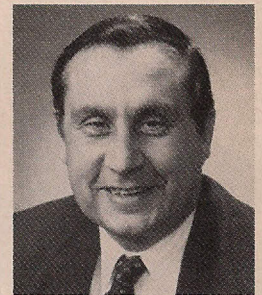
Retention Committee. Director Constantini is a chartered insurance broker with a regional insurance brokerage firm. He and his wife, Ann, have one daughter.
